NO.OSD/CHC/CTS&YAD/I-4/98: In exercise of the powers conferred by Sub-Section (1) of Section-6 of the Sindh Cultural Heritage (Preservation) Act 1994, the Government of Sindh are pleased to deciare the "CITY OF SHIKARPUR INCLUDING HOUSES CONSTRUCTED UPTO 1950 AND ITS WOOD AND IRON WORKS" as Protected Heritage within the meaning of the said Act.

- 2. In accordance with the Sindh Cultural Heritage (Preservation) Act 1994, Section-6(2), any objection to the issue of this Notification should be addressed to the Government i.e. Department of Culture, Government of Sindh, within one month from the date of this notification.
- 3. Any act intentionally to destroy, remove, injure, after and deface the imperil the Protected Heritage of Shikarpur or to build on or near the sites will be unlawful.
