Application should reach the undersigned on or before 02-03-2022 along with Educational Certificates from Matriculation onwards, experience Testimonials, CNIC, Domicile and Character Certificates and Two (2) References. Hard copies of filled application form should be submitted to the undersigned along with a Bank draft of Rs.3,000/- in favour of Director Finance, NED University. The candidates who have already applied for the following post are not need to submit the bank draft:

1	Civil Engineer	<ul style="list-style-type: none">• B.E/ BSc Engineering Civil from any reputed Engineering University / institute recognized by HEC/PEC.• Minimum 08 years post qualification experience in any Public / Private organization related to supervision of civil works.• Proven managerial capabilities in supervision of construction of Building works, and other related works.

Note:

Candidate should fill-in online form otherwise application shall be rejected.

1. Degree required or equivalent Degree from a recognized University / Institution shall be considered.
2. Since the appointment is on contract basis, therefore, maximum age limit is 58 years which can be further relaxed, provided that the competent authority, may in the interest of the University prescribe or waive the upper age limit subject to Physical Fitness.
3. Applications should be submitted along with all required complete documents. Candidates applying for more than one post must submit separate applications with necessary documents for each post.

4. Incomplete applications as well applications received after the due date will NOT be considered. Any direct or indirect approach or influence will result in disqualification.
5. Candidates already serving in Government / Semi-Government and Autonomous Bodies should apply through proper channel. Advance copies of the applications may be sent, so as to reach within the due date. However, their complete applications should have been received through Proper Channel before the Test/Interview, otherwise they will not be allowed to sit in Test/Interview, if shortlisted.
6. Applications, which are not submitted on prescribed forms (as mentioned at top above,) shall NOT be accepted. `

Only short listed candidates shall be called for Test / Interview.
