The meeting was convened to finalize the evaluation of bids for the work "**Relocation of Village Link Road at Thar Institute of Engineering, Sciences & Technology, Tharparkar**". A total of 04 bids were received, which were evaluated in detailed as per the evaluation criteria given in the tender documents and NIT by the project consultant M/S ESS.I.AAR. As per the detailed technical evaluation, M/S Hotchand Bhuromal is the only qualified bidder, which is also the lowest bidder.

Based on detailed technical evaluation by the project consultant and financial comparison of bids, the procurement committee recommends that the work may be awarded to lowest competitive bidder M/S Hotchand Bhuromal at the bid price of Rs. 9,850,182.00 which is 20% below the engineer's estimate of Rs. 12,311,493.00.
