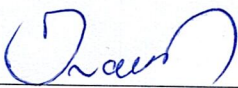

Meeting started with the name of Allah Almighty.

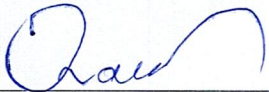
The Convener of the Procurement Committee welcomed the members of the committee on 25-01-2023 and opened the discussion on the agenda item.
