Only one bidder qualified the criteria in the technical evaluation.

Based on detailed technical evaluation and financial comparison of bids, the procurement committee recommends that the work may be awarded to the only qualified - most advantageous bidder **M/S Hotchand Bhuromal** for corrected bid price of Rs. 23,697,794.67 which is 17% above the estimated cost of Rs. 20.260 million.
