
**2. Bid of M/s. Khwaja Printers and Publishers for Rs 880,425/-**

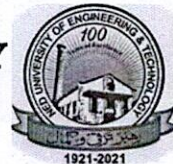
