**Online Registration Deadline: 16<sup>th</sup> October, 2020**

**Registration Procedure:**

Login to Online Registration System: (<http://www.neduet.edu.pk/usms>) by the deadline (**16<sup>th</sup> October, 2020**), print the registration request form, follow the registration guidelines and submit the form immediately after completion of all requirements in the concerned Department. Take the acknowledgement receipt from the Department.

**Fee Details:**

- Tuition & Examination Fee for BS (CF, AP, IC, TS, DS, MG, EG, EC): Rs. 34,500/-
- Tuition and Examination Fee for all other programmes 2<sup>nd</sup> year onwards: Rs. 25,500/-
- Rs. 1,500/= will be charged from the students of Bachelor of Architecture on account of Studio Fee.
- Rs. 1,000/= will be charged from the student of Industrial Chemistry on account of Bench Fee for Chemicals.
- Rs. 4,000/= will be charged for HSK-I Chinese language course for regular students.
- For each additional/ backlog course Rs. 5500/= per course will be charged.
- 20% Tuition fee discount will be adjusted in current fee voucher for those who have paid Registration Fee of Spring Semester, 2020.**

**Important Notes:**

- All students **must** register during Phase-I before **16<sup>th</sup> October, 2020**, irrespective of the announcement of Spring Session, 2020 Examination Results.
- Fee should be paid in the National Bank of Pakistan and Habib Metropolitan Bank, NED University (Main Campus) Branches only.
- Acceptance of registration by the University is subject to fulfilment of eligibility criteria (**see registration guidelines**).
- Selection of Additional/backlog courses shall be made accessible after announcement of results, only to those students who would have successfully registered themselves in **Phase-I**.
- Those having not registered online by 16<sup>th</sup> October, 2020 will neither be allowed to register after this date nor will be allowed to register for additional/ backlog course(s).**
