Fee Details:

- Tuition & Examination Fee for TIEST/BS (CF, AP, IC, TS, DS, MG, EG, EC): Rs. 35,000/-
- Tuition and Examination Fee for all other programmes 2nd year onwards: Rs. 26,500/-
- Rs. 1,500/= will be charged from the students of Bachelor of Architecture on account of Studio Fee.
- Rs. 1,000/= will be charged from the student of Industrial Chemistry on account of Bench Fee for Chemicals.
- Rs. 4,000 /= will be charged for HSK-II Chinese language course for regular students.
- For each additional/ backlog course Rs. 5,500/= per course will be charged.

- a) All students **<u>must</u>** register online before **<u>O5th</u> <u>March</u>**, **<u>2021</u>**, irrespective of the announcement of Fall Semester, 2020 Examination Results.
