- Tuition & Examination Fee for BS (CF, AP, IC, TS, DS, MG, EG, EC): Rs. 35,500/-
- Tuition and Examination Fee for all other programmes 2nd year onwards: Rs. 29,000/-
- Tuition and Examination Fee for TIEST, BS (CS) Rs. 35,500/-
- Rs. 1,500/= will be charged from the students of Bachelor of Architecture on account of Studio Fee.
- Rs. 1,000/= will be charged from the student of Industrial Chemistry on account of Bench Fee for Chemicals.
- Rs. 4,500/= will be charged for HSK-II Chinese language course for regular students.
